



Player Waiver, Release of Liability, and Indemnification Agreement between Participant and the City of Morristown, Tennessee

I, the undersigned (participant) player, acknowledge, agree, and understand that:

- 1. Voluntarily and of my own free will, I elect to participate as an individual or member of an adult sports team participating in a Morristown Parks and Recreation adult sports program with playing conditions, equipment, and other participants.
- 3. I understand that the nature of the sports is potentially hazardous and risky, including, but not limited to, the acts of standing, stretching, running, jumping, sliding, diving, collisions with other players and with stationary objects, all of which can cause serious injury to me and to other players.

Further, I, the signed player, agree that in consideration for the right to play as an individual or member of the team designated below and in consideration for permission to utilize the facilities arranged for use by Morristown Parks and Recreation:

- 4. I voluntarily elect to accept and assume all risks of injury incurred or suffered by me (a) while practicing or playing as an individual or member of the team so designated, (b) while serving in a non-playing capacity as an individual, team member or observer during practice or play by other teams or by other players on my team, and (c) while on or upon the premises of any and all of the facilities arranged for use by Morristown Parks and Recreation for practice or play.
- 5. I release, discharge, hold harmless and agree to indemnify and agree not to sue the City of Morristown, Tennessee, its officers, agents or employees, the team designated below, referees, or any person or entity connected with the team, league, or facilities, for any claim, damages, costs or cause of action which I have or may in the future have as a result of injuries or damages sustained or incurred by me from whatever cause including but not limited to the negligence, breach of contract or wrongful conduct of the parties hereby released.
